# I. CALL TO ORDER (Opening Prayer)

- b) The Board reviewed the Meeting Minutes from April 13th. The Minutes were unanimously approved.

### II. FINANCIALS

- Casie reviewed the year to date (YTD) financials as of May 4<sup>th</sup>, when our meeting was supposed to be held, and May 11<sup>th</sup>, the rescheduled meeting:

Next, Casie Reviewed the delinquency report. For the first time in at least four years, the delinquency rate has been below national average at 9%. (Natl. avg. 10-12%)

    - (3) Other Fees \$9,479 (Compliance Fines)
  - iii) BUDGET:

The second draft of the 2021 budget was reviewed by the Board for approval. The Board unanimously approved the 2021 budget at \$350 per homeowner, payable in 4 equal installments of \$87.50, as written. SMS will send statements out by June 15<sup>th</sup>.
